LICENSING IS REQUIRED

Your certification is valid for five years and will expire on 7/31/2029. There are 20 different pesticide use categories and subcategories. During the next five years you can certify in additional categories or subcategories. Be aware that all certifications will expire at the same time on 7/31/2029. After your certification expires you cannot use pesticides until you recertify by passing the appropriate certification exam in each pesticide use category or subcategory.
